Description of change/improvement that would impact fair registration outcomes:

· A new policy was adopted, Policy 2-25 Suitability to Practise for Applicants, which sets out the process that will be followed and the criteria that will be considered by the College when determining an applicant's ability to practise dietetics safely, ethically, and competently. This new policy provides greater transparency for applicants on the type of information that may be collected (as applicable) during the application process. • Policy 3-30: Assessing Currency for Applicants was revised to recognize graduate studies in dietetics, or a related area, competed within the preceding three years prior to the date of application, to demonstrate current dietetic knowledge, skills, and competence. Applicants demonstrating currency through completion of graduate programs are also required to submit a learning diary of all professional development activities completed within the preceding three years prior to the date of application. This policy change increases the options for applicants to demonstrate currency, especially those who have resigned from the College due to financial constraints while they complete additional graduate studies. • Revisions to Policy 4-50: Language Proficiency were incorporated to comply with section 3, Language proficiency testing requirements, of the Registration Requirements Regulation under the Regulated Health Professions Act, 1991 (RHPA), that came into force on January 1, 2023. The policy now accepts all types of language proficiency tests approved under the Canadian Immigration and Refugee Protection Act, provided the applicant's test results are within the preceding two years before the date of their application, and the test results are at minimum levels specified in Policy 4-50. The policy revisions reduce the time and financial implications of repetitive language testing requirements for applicants who are also seeking immigration in Canada and lengthen the validity of the language test results. • Revisions to Policy 5-30: Upgrading After Second Failure of the Canadian Dietetic Registration Examination (CDRE) provide a framework for applicants to develop an upgrading action plan that is based on their previous CDRE results and a self-assessment of learning needs. This revised upgrading approach strives to be empathetic and not overly prescriptive. It considers some of the challenges previously faced by applicants such as difficulty finding practicum supervisors and personal circumstances limiting access to academic and/or practicum upgrading (e.g., financial limitations, family commitments, etc.). An evaluation rubric has also been proposed to help streamline the Registration mmittaala raviaw and approval of an applicantle proposad

Committee's review and approval of an applicant's proposed Action Plan for Upgrading After a Second Failure of the CDRE, and the Director of Registration's review of the evidence of completion of upgrading activities, prior to approving the applicant to reattempt the CDRE for a third and final time. • The following revisions to Policy 6-10: Eligibility for Prior Learning Assessment and Recognition (PLAR) were incorporated to provide additional PLAR pathways for applicants, improve transparency, and reduce barriers to applicants seeking registration as a dietitian in Ontario: i. Applicants may begin the College's PLAR process to write the Knowledge and Competence Assessment Tool (KCAT) exam if they have not yet completed practical training. Those who obtain a KCAT Level I result (demonstrating sufficient academic knowledge and competence) are then eligible to apply to accredited practical training programs in Ontario, as well as other accredited practicum programs in Canada that recognize a KCAT Level I result. ii. Recognition of the World Education Services (WES) Gateway Program, which provides a means for individuals who have been displaced by adverse circumstances to have their academic credentials assessed. These applicants often have limited access to request their academic institutions send their transcripts directly to WES for assessment. The documents used for the WES Gateway Program credential evaluation come from the applicant and are not authenticated as done in a standard WES evaluation. If an applicant can demonstrate that they made attempts to obtain official documents but were unsuccessful due to personal circumstances, WES will conduct the Gateway Program assessment accordingly, and notes this on the evaluation report that is sent directly to CDO. iii. To ensure consistency in the College's policies for acceptable language proficiency tests to demonstrate language proficiency, revisions to Policy 6-10 were made to align with the revisions articulated above in Policy 4-50: Language Proficiency.

• The information on the Applicant landing web page was simplified to include the timelines, contact information for inquiries, and the acceptability of all documentation electronically, including the application form. • The KCAT web page was updated to provide information about the administration offered in 2022, updated technology requirements, and links to the updated KCAT Preparation Guide, with an updated list of references/resources. This information assists candidates to best prepare for the exam. It is publicly available on CDO's website, not just for candidates who are registered to take the KCAT. • The PBA web page was updated to provide information about the hybrid option for remote/in-person PBA administration offered in 2022, updated technology requirements, and links to the updated PBA Preparation Guide. This information clearly communicates the choice for candidates to take the PBA online or in-person and provides a valuable resource for candidates to prepare for the exam. This information is publicly available on CDO's website, not just for candidates who are registered to take the PBA. • The CDRE Preparation Guide is updated annually by the Alliance of Canadian Dietetic Regulatory Bodies. This resource is publicly available and posted on CDO's CDRE web page to help candidates prepare.

Description of change/improvement that would impact fair registration outcomes:

Effective April 1, 2022, Dietitians of Canada, announced they would discontinue the provision of accreditation services for the Partnership for Dietetic Education and Practice (PDEP), citing challenges related to financial sustainability. The Alliance of Canadian Dietetic Regulatory Bodies (the Alliance), which is made up of all 10 provincial dietetic regulators, has selected EQual as the new third-party accreditation provider. EQual has a Council/Forum which is made up of representatives all its sponsoring organizations/regulators, including the Alliance. The forum provides a venue for information sharing and feedback on EQual policies and processes. Further details on how the adoption of a new accreditation provider was sought are outlined below in Q12.

Description of Change/Improvement that would impact Fair Registration Outcomes:

In partnership with the Alliance of Canadian Dietetic Regulatory Bodies, the College took a collaborative role to select a new accreditation provider, with the former provider could no longer deliver accreditation services. The College's Board of Directors approved the new accreditation provider (EQual/Accreditation Canada) in July 2022, with a transition period until August 31, 2023. The College relies on accreditation to ensure that graduates of accredited programs have met the standards for entry-level practise and are ready to deliver quality, high-quality, dietetic care. Recognition of accredited programs enables the College to register applicants much quicker as no further equivalence assessment is required.

Description of Change/Improvement that would impact Fair Registration Outcomes:

• Upgraded the College's database. • Changed credit card processing vendors. Both changes noted above were completed to build in efficiencies for the Registration Program, streamline billing, reduce payment issues, and facilitate moving closer to a fully cloud-based platform for the future.

Description of Change/Improvement that would impact Fair Registration Outcomes:

The College offers both its PLAR exams, the Knowledge and Competence Assessment Tool (KCAT), assessing academic competence, and the Performance Based Assessment (PBA), assessing practicum competence, via online remotely proctored processes. These online formats improve access for applicants to take the PLAR exams from their home countries, without having to incur the expense of traveling to Canada. The College also offers the PBA via a hybrid option whereby candidates can take the PBA exam in-person at the CDO office. The in-person option follows a similar process to the online format but provides candidates with the required space and technology needs. To date, since the online format was offered, candidates have not requested to take the KCAT in-person, but the exam vendor (Touchstone Institute) is amicable to facilitate this upon request.

Revisions to Policy 4-50: Language Proficiency were incorporated to comply with section 3, Language proficiency testing requirements, of the Registration Requirements Regulation under the Regulated Health Professions Act, 1991 (RHPA), that came into force on January 1, 2023. In addition to the previously accepted language tests, the policy now also accepts the language proficiency tests approved under the Canadian Immigration and Refugee Protection Act: (English: CELPIP and IELTS General; French: TEF and TCF Canada) provided the applicant's test results are within the preceding two years before the date of their application, and the test results are at minimum levels specified in Policy 4-50. The policy revisions reduce the time and financial implications of repetitive language testing requirements for applicants who are also seeking immigration in Canada and lengthen the validity of the language test results.

By the end of 2022, the College was in compliance with the Registration Requirements Regulation under the RHPA that came into force on January 1, 2023. This included adherence to registration processing timelines, no requirement for Canadian Experience, and language proficiency.

Successful continued administration of both the PLAR Assessment exams (KCAT and PBA) via online-remotely-proctored processes.

Continued remote-work operations and acceptance of electronic documentation to facilitate efficient application and registration practices. This has also reduced the need for applicants to send hard-copy documentation to the College.

Withdrawal of the previous accreditation provider - The College worked closely with the Alliance of Canadian Dietetic Regulatory Bodies to establish a new accreditation provider that was approved by CDO's Board of Directors in July 2022. A transition period until August 31, 2023, was adopted and communications with the dietetic education programs are ongoing to facilitation onboarding.

Pause of Bridging Program at Toronto Metropolitan
University (TMU), attributed to funding, for
Internationally Educated Applicants - Mitigation
Measure: CDO continues to liaise with faculty at TMU
regarding continuation/remodeling of the program for
sustainability. Provincial and Federal funding sources
that CDO is aware of have been shared with TMU. CDO
is also researching other dietetics bridging programs in
Canada to determine the feasibility of establishing more
options for bridging programs for applicants. However,
the ability of candidates to retake the PLAR exams
(KCAT and PBA) is not contingent on completion of
bridging. Candidates can attempt up to three times and
create their own learning plan based on a report of their
knowledge and competency gaps.
